WI Always Active in AAUW

State President Joyce Hoffman reminded the 125 attendees from 21 branches that Wisconsin has always been active in AAUW from the start. founding mothers who gathered at MIT in 1881. Lois Rosenberry, from the Madison Branch, was Association president in 1921 when the organization consolidated nationwide and selected the name American Association of University Women. 1921 was also the year that Wisconsin became a statewide organization.

Title IX and Law's Requirements

Mollie Lam, LAF senior manager, and Tonya Schmidt, Asst. Dean of Students, UW-Madison, presented an update on

Title IX and the law's requirements of educational

institutions. Tonva said



that a new UW-System task force was launched last fall that should strengthen reporting and prevention of sexual assaults and other violations at all UW institutions. Both agreed that nearly 1 in 5 (20%) of women on campus suffer some type of traumatic harassment, sexual assault, date rape or stalking.
