The program, A Tour of Wisconsin through the Art of O.V. Shaffer, will be presented by Jerry Sveum. Jerry is President of Beloit Fine Arts Incubator and

served as Project Coordinator, along with wife Connie, for the O.V. Shaffer events: the ongoing, self-guided Road Trip, and the 4 simultaneous art shows in July of 2015. This virtual tour will follow segments of the O.V. Shaffer Road Trips from the summer of 2015 that visited his works across the state.

Verne graduated from Beloit College where he later taught art. For most of his career, he sculpted in Clinton, Wisconsin. His artwork consists of steel and brass, welded or cast, and wood and cast concrete. Several of his works are installed around Janesville.

His work is exhibited with major commissions throughout the United States. Verne has won multiple awards including awards from the Governor and lifetime achievement awards. In June, 2014 Shaffer received a Certificate of Recognition from Governor Scott Walker for having more public art than any other artist in Wisconsin and for his work as an art educator at Beloit College.

Everyone is welcome to participate in book discussion even if you have not come in the past.


